New Business the salary continuation usage report has come out Becky and Cheryl have reviewed it and have advised the folks with chronic issues, they have started highlighting extended medical leave, anything over 48 hours in a 6 month period. They now put the salary continuation on our checks does that correlate between 6 months or a calendar year. They use this to make sure if someone has a chronic illness they contact them about FMLA, they also want to check in with the supervisor to make sure they are on track. I have one who was never asked about her FMLA due to a chronic illness which is now in place due to this process. There is good and bad to the process.
 - a. Autumn DeRoo with the change to the 40 hours in a work week that has significantly reduced my SC time so I flex my hours and it has decreased that time.
