She is open to people emailing her questions and concerns. If a member asks what they can do – direct them to Rhonda or Becky, Deb is encouraging people to fill out the exemption. We appreciate Deb's willingness to do these meetings to hear the feedback. Ultimately if someone decides to separate from the university due to their beliefs she is looking at what that would look like for every individual. They hope to see everyone moving towards the vaccine. After the 30<sup>th</sup> there would be communication, she feels there could be further conversations or a warning to give people time. Encourage being on the town hall and see what they have to say, there may be additional questions after the town hall, we are open to following up with those discussions. At the end of the day it is up to the members if they want to continue their employment at GVSU.
